How to use the Account Summary Form:

- 1) Gather all completed entry forms, ticket requests, and applicable discounts.
- 2) Enter totals for # of entries and entry \$ (from bottom of entry forms) onto the top portion of the account summary
*please note that totals are first done for each "type" of entry form used. (i.e. Int'l Youth Amateur or Amer. Pro/Am, etc.)
(The entry tally section is for EBS only. If you are entering past this date, you may skip the totals on the left side of the form.)
MULTI-DANCE EVENTS COUNT AS ONE ENTRY
- 3) Enter \$ totals from VIP ticket form onto account summary.
- 4) Enter total entry & ticket \$ under "please total all purchases here". This is your grand total before applying any discounts.
- 5) Enter tally of Adult & Youth entry #'s into EBS box and multiply by \$ for total EB Savings (only for those entering in time for EBS).
- 6) Enter total \$ of any scholarship vouchers being redeemed (honored only when received at time of entry and payment).
- 7) Subtract total discounts from purchase total. This is your total balance due.
